## Why we want immediate full withdrawal and repeal:



Despite the latest amendment by the NSW Government the Code remains in place whilst the Rural Fire Service further reviews it.

We are concerned that the code will remain relatively intact after the RFS review and still fundamentally undermine biodiversity and protection of urban amenity (loss of shade, views, presence of birds, possums and other wildlife) as well as increase the heat island effect in large towns and cities, a growing consideration given global warming.

The Code is not science based, and flies in the face of strong evidence that tree canopies can shelter homes from burning embers riding on the wind generated by major bushfires. It is also a known fact that a strong tree canopy in residential areas can significantly mitigate violent windstorms often associated with severe thunderstorms. Scientists predict that



both severe bushfires and violent thunderstorms can be expected to increase in strength and frequency as global warming accelerates.

Many Councils have applied for exemptions from the Code and others have proposed amendments that, like the Government's changes to date, tinker around the edges of the main problem. Despite such amendments, the Code still



usurps an effective system of assessment and control already in place with cooperative arrangements and technical support by the RFS to local Councils. In addition, there is no guarantee that any Councils will receive an exemption and many have not even sought exemption. Continuing the Code also leaves it open to the Minister of the day to arbitrarily vary the Code or revoke previous exemptions and for developers, view seekers and tree haters to perhaps find loopholes even in Council areas supposedly exempt (assuming any are in fact exempted).
